CIRCULAR

Consequent upon **Revision of Variable Dearness Allowances** payable to the employees engaged in the Scheduled employment of **CONSTRUCTION OR MAINTENANCE OF ROADS OR RUNWAYS OR IN BUILDING OPERATIONS INCLUDING LAYING DOWN UNDERGROUND ELECTRIC, WIRELESS, RADIO TELEVISION, TELEPHONE TELEGRAPH AND OVERSEAS COMMUNICATION CABLES AND SIMILAR OTHER UNDERGROUND CABLING WORK, ELECTRIC LINES, WATER SUPPLY LINES AND SEWERAGE PIPE LINES**, vide Order **No. 1/36(3)/2019-LS-II dated 23.09.2019** of CLC(C), New Delhi under Notification No. **S.O. 188(E), dated 19th January, 2017** of Government of India, Ministry of Labour & Employment, New Delhi, the minimum rates of wages payable w.e.f. **01.10.2019 to 31.03.2020** will be as under:-

Area A: - Shall comprise of Ahmedabad (U.A.)

Area C: - Shall comprise of all other areas not included in Area A & Area B.

- U.A. means "Urban Agglomeration"

The following among other explanations have been appended to the said Notification No. S.O. 188(E) dated 19/01/2017.

1. Workers employed on high rise structures that is on or above **30 feet height**, even for one hour in a day, shall be paid **20 % (Percent) extra wages** of the minimum wages so fixed for the appropriate category.
2. Workers employed on **tunnel working** shall be paid **20% (Percent) extra wages** of the minimum wages fixed under the said notification for the appropriate category.
3. Where in any area the minimum rates of wages fixed by this notification are lower than the minimum rates of wages fixed by State Government for employees in employment in aforesaid Employment in relation to which the State Government is the appropriate Government, the rates of wages fixed by the State Government shall in respect of these areas, be deemed to be the minimum rates of wages payable under this notification.

4. Area "A" and Area "B" shall respectively comprise of all the places as mentioned herein above and include all places within a distance of **fifteen kilometres** from the **periphery** of Municipal Corporation or Municipality or Cantonment Board or Notified Area Committee of a particular place and Area "C" shall comprise of all the other places not mentioned in Area "A" and Area "B" to which the Minimum Wages Act, 1948 extends.

Further, consequent upon revision of Variable Dearness Allowance to the employees in the Scheduled employment of CONSTRUCTION OR MAINTENANCE OF ROADS, RUNWAYS OR IN BUILDING OPERATIONS vide notification No. L.C.6/T-2/1304 to 1403/2019 dated 30.09.2019 of Assistant Commissioner of Labour, Government of Gujarat, Gandhinagar, the minimum wages payable for the period from **01.10.2019 to 31.03.2020** will be as under:-

Zone – II shall comprise all the areas in the State of Gujarat other than those included in Zone-I


